TWO PURCHASING EMAIL ADDRESSES

For several months, State Purchasing has been utilizing two shared emails to streamline processes. The emails are to move information from the executive branch agencies to State Purchasing and then back to the executive branch agencies. The permanent email addresses allows several State Purchasing employees to share the workload, allow for consistency of service as workloads change, and allow for easier records search.

purchasingsolicitations@utah.gov

When an agency enters an RQS or RQM into FINET, they are required to send specification concerning the purchase to State Purchasing. The purchasingsolicitations@utah.gov email was created to accept procurement specifications in one location. At bare minimum, the agency must include the RQS or RQM number in the subject of the email and add the specifications in the body of the email. The agency can choose to attached the specifications or other documents to the email as needed or required.

Recently, State Purchasing has experienced an increase of duplicate RQS & RQMs entering our workload. This occurs when an agency changes an RQS or RQM in FINET after State Purchasing has accepted the work. If changes are made to an RQS/RQM, the agency must send an email to purchasingsolicitations@utah.gov

including RQS/RQM number in the header and state in the body of the email that the RQS/RQM has been updated in FINET and that this is a duplicate solicitation. Any updated specs can be sent with the email, if needed.

Are you having a problem with a contract in FINET? This email is for the following situations:

- 1) Late invoices after contract closed,
- 2) A canceled warrant that was not connected back to the contract,
- 3) Money returned from contracted vendor,
- 4) A payment of an invoice made on the wrong contract, or
- 5) A contract which needs to be canceled in FINET.

Each of the above situations require a little help from State Purchasing, if it is a State Purchasing contract (the number 6 is in the third position from the left). When these situations occur, please send an email to purchasingcontracts@utah.gov. The technician will let you know what paperwork is required to verify and complete the request. When the work is completed, a return email from purchasingcontracts@utah.gov to inform the agency.
