Subject: Emergency Procurement

The veteran's cemetery pumps water from a canal for irrigation. When a pump goes down, immediate action is required to remedy the problem as quick as possible to ensure the health of the grass and the presentation of the cemetery. Vendor, Bartok Controls, Inc. has been working with us to resolve the problem. The initial intent was to replace the pump with a new one but we ran into supply chain issues which forced us to repair the existing pump.

The cemetery supervisor, Arnold Warner, has kept me informed of the issue. UDVMA Executive Director, Gary Harter, authorized me to move forward under the emergency procurement provision.

We have been waiting for final word on the cost to repair the pump. We received the invoice on May 24th, 2002. The total cost is \$6,171.74.

Going forward we plan to purchase a new pump under normal procurement procedures and have it available for the next time this happens.

This is to document your approval for an emergency procurement relating to the repair of the irrigation pump at the veterans cemetery.
