PURCHASING UPDATE

Utah Public Procurement Certification Program

The Chief Procurement Officer has created a Utah certification program which, when obtained, proves the public procurement professionals' knowledge of the Utah Procurement Code. Two certification levels are available: Public Procurement Professional Certification (PPPC) and Public Procurement Manager Certification (PPMC).

Public Procurement Professional Certification (PPPC)

This is an open book exam with the book being the Procurement Code. In addition, beginning at the March PEP Seminar, specific Procurement Code instruction will be provided at break-out sessions to help those preparing for the PPPC certification.

Public Procurement Manager Certification (PPMC)

This is a closed book exam. Individuals seeking to obtain the PPMC, must successfully complete the PPPC certification process. There is no additional instruction for the PPMC, instead, public procurement professionals must obtain a clear understanding of the Utah Procurement Code through individual study and application.

Utah Public Procurement Certification Program

At this time, we anticipate that these will be a lifetime certifications as a recertification exam has not been planned, however, this may change in the future.

At the December PEP Seminar, Kent Beers was asked how much time would be allowed to take the exam. He responded that there is no time limit set and that the length of time required "depends on the individual." He further recommended that exam takers allow a couple of hours.

- Open-Book Exam
- No Minimum Number of Years Experience Required
- Exam May Be Taken at Division of State Purchasing. It maybe online in the future.

PPMC (Public Procurement Manager Certification)

- Cost \$200 Paid by NASPO for Members of UT Cooperative
- Must Have PPPC Certification
- Exam Based on Utah Procurement Code
- Closed-Book Exam
- Exam May Be Taken at Division of State Purchasing

State Cooperative Contract: Election Systems & Software

We are extremely excited to announce that the State of Utah has designated Election Systems & Software as the state's election management vendor under contract number AR2762.

The evaluation committee was comprised of representatives from the Utah Lieutenant Governor's Office and various counties across the State of Utah, as well as a representative for Voters with Disabilities — and to ensure that the process outlined in the State's Procurement Code was followed, a representative from the State's Division of Purchasing, who served as a non-voting member of the evaluation committee, also attended the committee meetings.

Below are some highlights of ES&S's systems and capabilities:

- The Election Management System provides an efficient and intuitive process for ballot layout and design, as well as import and export capabilities that facilitate the exchange of data with Utah's statewide voter registration system.
- There is a solid tabulation solution for every Utah county, including those that have adopted a
 full vote by mail process, as well as assorted options for scanning and tabulating paper ballots
 for counties from small to large.
- The high-speed tabulators will significantly speed ballot processing time and provide an efficient process for adjudicating ballots that cannot immediately be scanned (blank ballots, write -ins, ballots where a voter has marked more than the acceptable number of candidates, or ballots that are otherwise unreadable by the scanners).
- The accessible voting solution combines paper-based voting with touch-screen technology to meet the needs of voters with disabilities as well as provide a permanent paper record, as required by Utah statute.
- There are offered support and maintenance plans at different levels of service and price points so that counties can select the option that best meets their individual needs.

The Utah Division of Purchasing is recognized as one of the best managed public procurement agencies in the nation. State Purchasing manages over 800 cooperative contracts for goods and services used by state agencies, local governments and educational entities across the State. Cooperative contracting brings together the buying power of all government entities resulting in lower prices through volume discounts, higher quality goods and services, and stronger contract terms and conditions.

Optional Weekly Training

Aristotle once said, "The beginning of wisdom is to define." In seeking wisdom, the Division of Purchasing began holding internal weekly procurement staff training sessions to understand the defined processes and comprehend subsections of the Procurement Code and Administrative Rule R33. The weekly subject was limited to one or two subsections in order to focus understanding. We have found this to be very beneficial in gaining "wisdom."

Beginning December 6, the Division is opening the weekly procurement training sessions to any public procurement staff that would like to attend. The training sessions are held on Wednesday from 9:00 am - 10:00 am in a room at the Capitol Hill Complex.
